

Quadvent 2 - End User License Agreement v3.0 - January 2018

The END-USER LICENSE AGREEMENT ("EULA") FOR QUADVENT 2

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: Health & Safety Laboratory End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Health & Safety Laboratory, for the Health & Safety Laboratory software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("QUADVENT 2"). By installing, copying, or otherwise using QUADVENT 2, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Health & Safety Laboratory, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use QUADVENT 2.

QUADVENT 2 is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. OUADVENT 2 is licensed, not sold.

1. GRANT OF LICENSE.

QUADVENT 2 is licensed as follows:

(a) Installation and Use.

The Health & Safety Laboratory grants you the right to install and use copies of QUADVENT 2 on computer(s) for which you hold both a validly licensed copy of QUADVENT 2 and the operating system for which QUADVENT 2 was designed [e.g., Windows 7, Windows 8, Windows 10].

(b) Backup Copies.

You may also make copies of QUADVENT 2 as may be necessary for backup and archival purposes.

(c) Duration of licence.

Perpetual licences allow QUADVENT 2 to be used indefinitely. For annual licences QUADVENT 2 may not be used after the expiration of the licence unless a further annual licence is purchased.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of QUADVENT 2.

(b) Distribution.

You may not distribute registered copies of QUADVENT 2 to third parties.

(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble QUADVENT 2, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental.

You may not rent, lease, or lend QUADVENT 2.

(e) Support Services.

Health & Safety Laboratory may provide you with support services related to QUADVENT 2 ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of QUADVENT 2 and subject to the terms and conditions of this EULA.

(f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of QUADVENT 2.

3. TERMINATION

Without prejudice to any other rights, Health & Safety Laboratory may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of QUADVENT 2 in your possession.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to QUADVENT 2 and any copies thereof are owned by the British Crown or its suppliers, and are administered by Health and Safety Laboratory under a Delegation of Authority granted by the Controller of Her Majesty's Stationery Office (dated 26th June 2008). All title and intellectual property rights in and to the content which may be accessed through use of QUADVENT 2 is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by the Crown.
